CUBA At least 52 people on death row

Amnesty International is concerned that at least 52 people on death row may be imminently executed, following the execution of Lorenzo Enrique Copello Castillo, Bárbaro Leodán Sevilla García and Jorge Luis Martínez Isaac on 11 April. The executions marked the end of a *de facto* moratorium practiced by the Cuban authorities since April 2000.

On 11 April, Lorenzo Enrique Copello Castillo, Bárbaro Leodán Sevilla García and Jorge Luis Martínez Isaac, were executed by firing squad in Cuba. The men had reportedly hijacked a Cuban ferry on 2 April and tried to force it to take them to the United States. When the ferry ran out of fuel off the coast of Cuba, the men allegedly threatened the lives of passengers. The ferry was escorted back to harbour in Cuba, and after a standoff of several days, the incident was resolved without violence.

The three men were part of a group of eleven accused of participating in the hijacking. They were convicted under toughened anti-terrorism legislation passed in December 2001 which allowed for the use of the death penalty in extreme cases. Their appeals to the Supreme Court and the Council of State were summarily dismissed, and the three were executed by firing squad less than a week after their trial began. The others accused received less severe sentences.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish, English or your own language:

- expressing concern at the resumption of executions following Cuba's three-year *de facto* moratorium on executions:
- acknowledging that those on death row were often convicted of heinous crimes, and expressing sympathy for the victims= families and friends, but pointing out that the death penalty has never been shown to deter crime more effectively than other punishments;
- reminding the Cuban authorities that international due process guarantees must be fully respected at all times:
- expressing unconditional opposition to the death penalty in all cases as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading punishment;
- urging President Castro and the Cuban authorities to commute these and all other pending death sentences, and not to pass any further death sentences.
