CUBAOlance NOGUERAS ROCE (note full name and corrected spelling), aged 27, journalist working with the Buró de Periodistas Independientes de Cuba (BPIC), Bureau of Independent Journalists of Cuba

Amnesty International has learned that Olance Nogueras Roce was re-arrested on the evening of 26 October in Havana and is believed to be detained in Ariza Prison in Cienfuegos, his home town.

Olance Nogueras Roce has been arrested three times in the past few weeks. On 7 October he was briefly detained by police in Cienfuegos and warned that he had 30 days to find a job with a state entity or else face charges of "dangerousness" ("peligrosidad"). On 20 October, he was again arrested after participating in a weekly press conference held by the Ministry of Foreign Affairs in Havana. His place of detention was not known at first but it later emerged he had been taken to Ariza Prison, Cienfuegos, where he was held for five days. While in detention, he was reportedly told that if he did not leave the country by 7 November, he would be re-arrested and tried for "dangerousness". Upon release on 25 October, he was warned not to leave Cienfuegos. However, he immediately defied the order and returned to Havana to go to the BPIC office (which is also the home of Yndamiro

Restano Díaz, former prisoner of conscience and founder of BPIC) where he spoke on the telephone to contacts abroad about his arrest. The house was surrounded by State Security officials and the phone line cut off. The police later left and Olance Nogueras was able to leave the building. However, he returned to BPIC next day to work and in the evening the police arrived and arrested him again. He was reportedly taken back to Ariza Prison, although his family has not been able to see him. The authorities have not publicly confirmed his arrest or the reasons for it. Apart from the previous threats of being charged with "dangerousness", one so far unconfirmed report suggests that he may be charged with "enemy propaganda" because of an article he wrote regarding safety fears at the Cuban nuclear power station in Juragua, near Cienfuegos.

# FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or in your own language:

- expressing concern at reports of the arrest of Olance Nogueras Roce;
- urging that he be immediately and unconditionally released unless charged with a recognizable criminal offence;
- urging that members of the BPIC and other freelance journalists be permitted to carry out their legitimate work without interference from the authorities.
