EL SALVADOR: Proposed Amnesty Law would block investigations into

human rights violations

Amnesty International is deeply concerned that the Salvadorian parliament is considering a draft law which would grant a sweeping amnesty to those responsible for human rights abuses, committed on a massive scale during the country's civil war (1980-92).

The draft law (proyecto de ley) was presented to the Legislative Assembly (parliament) on 15 March 1993 and is to be debated and voted on on 18 March. If approved, the law would shield from prosecution perpetrators of serious human rights abuses, including mass killings and other extrajudicial executions, "disappearances", and torture.

BACKGROUND INFORMATION

The draft law was introduced a day after the publication of a report by the Truth Commission (Comisión de la Verdad), a United Nations-appointed body set up to investigate human rights abuses during the war by the Armed Forces and by the armed opposition FMLN. The Truth Commission's report produced overwhelming evidence of the Salvadorian army's involvement in human rights abuses on a massive scale. It also established that the FMLN was responsible for a number of extrajudicial executions.

Amnesty International believes that the work of the Truth Commission would be seriously undermined if, instead of bringing to justice those identified as responsible for past human rights abuses, the government immediately amnesties them. Passing an amnesty law before justice has been done would not only contradict the spirit of the Truth Commission's recommendations, but would be in violation of Salvadorian law and international standards.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes either in Spanish, English or in your own language:

- noting the unprecedented and important work of the Truth Commission as part of the process of national reconciliation;
- expressing serious concern at the subsequent presentation of a draft amnesty law which could seriously undermine the Commission's work;
- pointing out that an amnesty law granting immunity to human rights violators

would not only contradict the spirit of the recommendations of the truth Commission but would contravene Salvadorian law and international human rights standards to which El Salvador is party;

- urging the government not to approve any law which would block investigations into human rights abuses and would prevent the prosecutions of those responsible.
