Amnesty International is concerned about continuing threats and harassment against Amílcar Méndez Urízar, parliamentary representative of the Frente Democrático Nueva Guatemala (FDNG), "New Guatemala" Democratic Front, and founder member of the CERJ Council of Ethnic Communities "We are all equal", (Consejo de Comunidades Etnicas "Runujel Junam"), and his family.

According to reports, on 11 April 1995, at 1pm, when his daughter Tomasa Micaela Mateo Taquiej came back home, she found four unidentified and heavily armed men who had broken into Amílcar Méndez's house. She was blindfolded and forced to drink a unspecified drug and was later found by her sister unconscious and undressed. She is currently undergoing medical tests to determine her condition. Reportedly, some money left on the table to pay bills was not stolen during the assault.

On 10 April 1996, Amílcar Méndez received a letter from the "Jaguar Justiciero", a "death squad", in which he was accused of being a communist. The same day that this incident happened, members of the FDNG were giving a press conference denouncing that they had received death threats signed by this death squad.

The UN Mission for the Verification of Human Rights in Guatemala (MINUGUA, Misión de las Naciones Unidas de Verificación de Derechos Humanos en Guatemala) and the Human Rights Procurator have already initiated a investigation into the incident.

In October 1995, Amílcar Méndez and his family suffered similar incidents (see original Urgent Action and previous follow-up, and see also Continuing harassment against Amílcar Méndez Urizar and his family, AMR 34/50/92, for further information about other incidents os harassment against him and his family).

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or in your own language:

- calling for immediate steps to be taken to guarantee the safety of Amílcar Méndez Urízar and his family;
- calling for an immediate and thorough investigation into the reported incidents, including death threats to members of FDNG, and that those responsible be brought to justice;
