GUATEMALA: Axel MEJÍA, Street educator

Amnesty International is concerned at the recent series of threats received by Axel Mejía, a street educator with Covenant House (Casa Alianza), an organization which works with street children in Guatemala and has been in the forefront of efforts to investigate recent police abuses against children, including harassment, torture, "disappearance" and killings.

At approximately 1.00pm on Tuesday, 30 April 1991, a telephone call was made to the Casa Alianza office by a male who did not identify himself and who stated "que le dijera a Axel Mejía que tiene 24 horas para salir de Casa Alianza" ("tell Axel Mejía that he has 24 hours in which to leave Casa Alianza"). Some 15 minutes later the same person called again saying "queremos repetir el mensaje para Axel Mejía que tiene 24 horas para salir de Casa Alianza" ("we want to repeat the message to Axel Mejía that he has 24 hours in which to leave Casa Alianza"). A third telephone call was made to Axel Mejía's mother's home on Sunday 28 April. Again a male who did not identify himself said "que Axel Mejía tiene 72 horas para salir de Casa Alianza" (Axel Mejía has 72 hours to leave Casa Alianza). Casa Alianza reported that the first two calls were made their new offices in Zone 1 of Guatemala City, to a telephone number which has not as yet been made public, and that only those persons with direct access to the telecommunications network, would have known the new telephone number.

Axel Mejía has been the principal witness to an incident which occurred on 7 November 1990, when thirteen members of the police unit <u>Sistema de Protección Cívica</u> (SIPROCI), System of Civil Protection, and of the security forces (four National Policemen, five members of the Treasury Police and four Military Police), beat three street children in front of a refuge run by Casa Alianza. Legal proceedings have been initiated against one of the Treasury Police, identified as the principal aggressor. Axel Mejía gave evidence in the criminal proceedings against the accused agents two weeks ago, and it is believed these threats may be directly related to his evidence on these proceedings.

FURTHER RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters:

- expressing concern at the latest in a series of threats made against Axel Mejía, apparently related to his evidence in legal proceedings against members of the security forces;

- asking that these threats be investigated, and that those found responsible be brought to justice;
- calling for protection for Axel Mejía and all those working to protect street children.
