Amnesty International is seriously concerned for the safety of Silverio Pérez de León, César Augusto Gómez Rodríguez and Leonardo Álvarez, members of the political party, Frente Democrático Nueva Guatemala (FDNG), New Guatemala Democratic Front in Santa Cruz del Quiché, department of El Quiché, following a series of death threats, harassment and intimidation allegedly by members of the security forces over the last few months.

On 11 April 1997, Silverio Pérez de León, Mayor of Santa Cruz del Quiché, received a letter signed in the name of the "Jaguar Justiciero", a death squad which had links to the armed forces during the 1980s, with the signing-off, "atentamente Ángel", "yours faithfully, Ángel" and bearing the symbol of the hammer and sickle. The letter accused him of providing food to the nearby camp of demobilized members of the Unidad Revolucionaria Nacional Guatemalteca (URNG), Guatemalan National Revolutionary Unity, and said that he had to leave Santa Cruz de El Quiché within 15 days.

This is the latest in a series of verbal, written and telephone threats that Silverio Pérez de León has received over the last eight months. In August and November 1996, unidentified men broke into his house and robbed some belongings and animals that he had in the garden. He has also received at least two letters accusing him of being a member of the guerrilla forces and threatening him with death if he did not leave Santa Cruz del Quiché. In January 1997, a man in civilian clothes, allegedly linked to the military base in El Quiché, told him: "fijate que estás en problemas, es mejor que te vayas del país o de la municipalidad", "You are in trouble, you'd better leave the country or the area". From January to April 1997, he received death threats via repeated telephone calls to his office in Santa Cruz del Quiché.

On 28 March 1997, at 11pm, César Augusto Gómez Rodríguez, the FDNG's electoral campaign coordinator, was detained by members of the National Police of Santa Cruz de El Quiché while he was driving with two other people. He was detained for more than eight hours in the National Police Station and released without charge. In February 1997, César Augusto Gómez reported to the Public Ministry [Ministerio Público] that since October 1996 he had been intimidated by the police and military members because of his connection with the FDNG. On 8 February 1997, he was followed by a uniformed man and four others in plain clothes as he left a well-known restaurant in Santa Cruz de El Quiché.

Although César Augusto Gómez has presented the Public Ministry with a list of 14 people, among them members of the security forces whom he had recognized as the originators of the death threats, to date none of them have been called upon to give statements.

During the night of 20 April 1997, unidentified men broke into the home of Leonardo Álvarez, a well-known FDNG activist in Santa Cruz de El Quiche. According to the information received by Amnesty International the men searched the house, but took nothing.

RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish or your own language:

- expressing concern for the safety of Silverio Pérez de León, César Augusto Gómez Rodríguez and Leonardo Álvarez members of FDNG
- calling for immediate and adequate measures to guarantee the safety of Silverio Pérez de León, César Augusto Gómez Rodríguez and Leonardo Álvarez and all members of FDNG;
- calling for an immediate and thorough investigation into the reported incidents, including deaths treats of members of FDNG, and urging that those responsible be brought to justice.
