## GUATEMALA Víctor Hugo Cano Recinos, defence lawyer

Amnesty International is concerned for the safety of Víctor Hugo Cano Recinos, a defence lawyer who has recently received threats and been subjected to intimidation as a consequence of his involvement in a high profile case in Guatemala concerning three former policemen sentenced to death in May 1996 for murder and attempted murder (see UA 208/97, AMR 34/27/97, 10 July 1997).

The decision by Guatemala's Constitutional Court in April 1998, provisionally suspending the execution of the three men pending a further appeal, may have placed Victor Recinos in a greater position of vulnerability.

On 21 May 1998, Víctor Cano was approached by an armed man in Guatemala City who questioned him about the above case. On 5 June he received a number of threatening telephone calls warning him to withdraw from this case and from another one concerning a kidnapping. The caller claimed to have information which could implicate Víctor Cano in the recent murder of a district attorney and threatened to divulge this information to the press if he did not comply.

## BACKGROUND INFORMATION

Former policemen Miguel Angel Revolorio Rodríguez, Miguel Angel López Calo and Aníbal Archila Pérez were sentenced to death in May 1996 for murder and attempted murder, crimes which they allegedly committed in 1995.

Victor Recinos, and other lawyers acting on behalf of the three former policemen, contend that the proceedings against them fell far short of acceptable standards of due process and that the procedure under which they were identified as being responsible for the attempted murder was highly questionable as to make it invalid. They argue that these failings have thereby resulted in unfair convictions.

## RECOMMENDED ACTION: Please send telegrams/E-mails/faxes/express/airmail letters in Spanish or your own language:

- expressing concern at the recent threats directed at defence lawyer Víctor Hugo Cano Recinos and urging the authorities to take all the necessary steps to guarantee his safety particularly during the course of further proceedings on the case involving the three former policemen;
- urging the authorities to investigate these threats and bring those responsible to justice;
- urging the authorities to ensure that Víctor Hugo Cano Recinos can freely and openly perform his legitimate duties as a defence lawyer in accordance with the 1990 United Nations Basic Principles on the Role of Lawyers, in particular principle 16 stating:

"Governments shall ensure that lawyers [...] are able to perform all of their professional functions without intimidation, hindrance, harassment or improper interference; [..] and shall not suffer, or be threatened with, prosecution or administrative, economic or other sanctions for any action taken in accordance with recognised professional duties, standards and ethics."
