Workers and trade union leaders at the Lunafil S.A. textile factory in Amatitlán, Department of Guatemala, are reported to have been subjected to repeated death threats and other acts of intimidation since May 1994, when a group of 49 of them began a protest outside the factory against what they claim to be its illegal and unjustified closure with the subsequent loss of 200 jobs. A spate of recent threats has greatly heightened concern for the safety of those named above.

Incidents reported to Amnesty International include:

• May - unknown men carrying weapons went to José Gil's home several times to threaten him;

• 6 October - a group of masked men violently intercepted Débora Guzmán and threatened to kill her within 48 hours if her husband, Félix González, and Julio Coj did not stop their union activities;

• 7 October - the offices of the Unión Sindical de Trabajadores de Guatemala (UNSITRAGUA), Guatemalan Workers Labour Union, to which Lunafil's trade union is affiliated, received several anonymous phone calls. In the last of these, the callers stated that they were holding Débora Guzmán and that her life was in her husband's hands;

• 8 October - Débora Guzmán and Félix González received an anonymous letter at home reiterating the threats.

Other members of the family of Débora Guzmán and Félix González are also reported to have been subjected to acts of intimidation; in one incident Félix González's brother was shot at by unknown individuals.

The workers suggest that members of private security guards, hired by the Lunafil management during another dispute in 1987 and 1988, may have been responsible for some of these incidents. No official investigation has been opened.

BACKGROUND INFORMATION

Trade unionists have been a long-term target of human rights violations in Guatemala and recent months have seen a renewed wave of abuses against them.

In a previous dispute at Lunafil, from June 1987 to May 1988, Lunafil's workers carried out an occupation after labour negotiations broke down due to disagreements over working hours and conditions that management were trying to impose, and which the workers said were in breach of Guatemala's Labour Code. On 27 May 1988, Julio Coj was shot at, reportedly from a police car, when riot police was trying to end the occupation.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing concern at the serious threats and acts of intimidation against

Félix González, Julio Coj, José Gil and Débora Guzmán;
urging the government to take immediate measures to guarantee their safety and that of their families;
asking the government to take measures to guarantee the safety of all Lunafil workers, especially those demonstrating outside Lunafil S.A.;
asking that these incidents be fully investigated and that those found to be responsible be brought to justice;
stressing that, as private security firms must, by law, be licensed by the National Police and the Ministry of Interior, Amnesty International considers the Guatemalan authorities responsible for investigating these incidents and bringing the perpetrators to justice.
