UA 363/02 Fear For Safety 16 December 2002

GUATEMALA Amílcar Méndez (m), Human rights activist and his family.

Amnesty International is seriously concerned for the safety of human rights activist Amílcar Méndez and his family. He was fired upon and robbed by an unidentified gunman on 12 December, near his home in Mixco, Guatemala City. He was not injured in the attack, but had a number of items stolen including personal documents, cash and a mobile phone.

Amílcar Méndez, founder of one of Guatemala's first human and indigenous rights organisations *El Consejo de Comunidades Etnicas, Runujel Junam* (CERJ), The Council of Ethnic Communities, *Runujel Junam* ('We are all equal') and his family remain deeply shocked and afraid following the attack.

Due to his work with CERJ, which has focused mainly on demilitarization and the human rights of indigenous peoples, Amílcar Méndez and his family has been the target of numerous attacks and threats dating back to 1988. They were forced to seek temporary asylum abroad on several occasions (see UA 128/91, AMR 34/13/91, 18 April 1991; UA 289/91, AMR 34/40/91, 28 August 1991; fu UA 30/95, AMR 34/11/96, 12 April 1996). However, this is the first direct threat on Amílcar Méndez's life in recent years. Increasingly it has become a pattern in Guatemala for attacks on human rights defenders to be carried out in such a way that they appear as common crime. However, Amnesty International fears that the motive for the attack may be his long term involvement in human rights work, particularly his prominent role in efforts to locate a missing indigenous lawyer, Antonio Pop Caal, who disappeared from his home in Cobán, Alta Verapaz Department two months ago, and whose whereabouts remain unknown.

Since the mid-1980s, Amílcar Méndez has been one of the key figures in the human rights movement in Guatemala and the recipient of a number of international human rights prizes. In 1996, he was elected to Congress as representative for the popular leftist party, *El Frente Democrático Nueva Guatemala* (FDNG), The New Guatemalan Democratic Front, where he served until 2000.

#### **BACKGROUND INFORMATION**

In recent years, the harassment and intimidation of human rights defenders in Guatemala has escalated dramatically, intensifying since February with a wave of attacks against human rights and indigenous rights activists. Amnesty International is concerned that the Guatemalan authorities are failing to take demonstrable steps to protect human rights defenders, commitments to which they are bound under the Peace Accords signed in 1996 and national and international law.

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- urging the authorities to offer immediate protection to Amílcar Méndez and his family;
- calling on the authorities to carry out an immediate, exhaustive and impartial investigation into this incident, bringing those responsible to justice and making the results public;
- insisting that the failure to clarify this grave incident can only be seen by the international community as evidence of the Guatemalan authorities' unwillingness or inability to deliver on their frequently repeated promises to the international community to protect human rights defenders and take concrete steps to ensure a return to the rule of law.
