HAITI: Staff and children at the Centre d'Education Populaire children's home and the orphanage "Lafanmi Selavi"

Killed:

Saurel GUERRIER, aged 17

Amnesty International is concerned about the killing of Saurel Guerrier, who was reportedly shot in the heart in Port-au-Prince on 15 January 1994. According to reports, his assailant, known by the name of Jodell, is a member of the new political group called Front Révolutionnaire pour l'Avancement et le Progrès Haitien (FRAPH), Revolutionary Front for the Advancement and Progress of Haiti. This group is widely reported as a front group for the attachés (armed auxiliaries to the security forces).

Saurel Guerrier was one of the 186 boys and girls living at the "Centre d'Education Populaire", one of the three children's homes in Port-au-Prince. Sources in Haiti suggest the boy may have been singled out because his assailant may have mistakenly believed that he was connected to a children's home in Port-au-Prince called "Lafanmi Selavi".

"Lafanmi Selavi" (<u>La famille c'est la vie</u>) was founded by president Jean-Bertrand Aristide in 1986 and, since the *coup d'etat* of September 1991 in which president Aristide was deposed, both staff and children there have been, and continue to be, the target of numerous violent attacks by the security forces or, on some occasions, by men in civilian clothes ostensibly linked to them.

## BACKGROUND INFORMATION

Amnesty International knows of a series of previous attacks on staff and children associated with "Lafanmi Selavi". In April 1993, staff and children at the orphanage received threatening phone calls and suffered other acts of harassment, reportedly carried out by a group of approximately 10 attachés (see UA 118/93, AMR 36/13/93). On 16 August 1993, the security guard at "Lafanmi Selavi" was reportedly abducted by some unknown individuals and was found two days later, naked, with his head shaven and in deplorable physical condition. Most recently, on 24 October 1993, police severely beat Jean René, aged 18, who had grown up in the orphanage. That day he had been interviewed by foreign journalists about the repression which he and other young people associated with the orphanage had endured. Afterwards, police reportedly accused him of being "a spy for the foreigners".

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in French, English or in your own language:

- urging an investigation into the killing of Saurel Guerrier and that those found responsible be brought to justice;
- urging that immediate steps be taken to guarantee the safety of staff and children of the "Centre d'Education Populaire" and of the "Lafanmi Selavi"

children's homes.
