# EXTRA 17/92 Legal Concern/Fear of Ill-treatment 19 February 1992 HAITI: Cadet ANTOINE

Amnesty International is concerned at reports of the arbitrary arrest of Cadet Antoine, a *technicien* (technician) with the <u>Movement Paysan de Papaye</u> (MPP), Papaye Peasant Movement. The arrest was carried out in Hinche, Centre Department, on 15 February 1992.

According to information received, Cadet Antoine was attending a service at the <u>Eglise Baptiste Indépendente</u> (Independent Baptist Church), in the city of Hinche, when soldiers interrupted the service and took Cadet Antoine away. He was taken directly to Hinche prison, where he is currently being held. No information has emerged as to the reasons for his arrest, but sources in Haiti have expressed fears that his arrest may have been related to his MPP membership. Amnesty International is concerned that he may be ill-treated in custody.

#### BACKGROUND INFORMATION

Troops overthrew the democratically elected government of President Jean-Bertrand Aristide, who took office in Haiti on 7 February 1991, in a coup on the night of 29 to 30 September 1991. Since then Amnesty International has learned of widespread human rights violations committed by the security forces, including a large number of extrajudicial executions, torture and ill-treatment and mass arrests without warrant. These abuses have been carried out by uniformed security force agents or, on some occasions, by men in civilian clothes ostensibly linked to them.

Grassroots and peasant organizations have been particularly targeted for repression by the security forces and their civilian counterparts. The MPP has been a long-term target of the armed forces under previous regimes in Haiti. The leadership of the MPP reported that following the coup soldiers from the city of Hinche were drafted into the town of Papaye to seek out the entire MPP leadership, who then went into hiding. The offices of the MPP were ransacked by soldiers.

On 16 October 1991 MPP member Aldajuste Pierre, president of <u>Kosmika</u>, an MPP cooperative was arrested by soldiers in Hinche. While in Hinche prison he was reportedly very badly beaten, and was subsequently transferred to the military hospital in Hinche with blood in his urine. Another leading member of the MPP, Dr. Dieudonné Jean-Baptiste, the brother of the MPP's president, Chavannes Jean-Baptiste, was arrested by police in Port-au-Prince on 17 December 1991. He was subsequently released. Ten days later soldiers had ransacked the home of Chavannes Jean-Baptiste, only one week after the home of two Belgian voluntary workers with the MPP, was ransacked by soldiers (see <u>Haiti: The Human</u> Rights Tragedy - Human rights violations since the coup, AI Index: AMR 36/03/92,

January 1992).

- expressing concern at the reported arbitrary arrest of Cadet Antoine;

- asking that his physical integrity be guaranteed while in detention;

- asking for clarification as to the reasons for his arrest and his legal status.
