HAITI: Guy TELVA, (radio journalist)

Amnesty International is concerned for the safety of Guy Telva, a journalist for the Voice of America radio after a series of recent death threats against him.

According to the testimony of Guy Telva, armed men in plain clothes, believed to be members of the security forces, went to the district of Delmas in Port-au-Prince, where he lives, at the end of February 1992, and asked neighbours where he lived. The neighbours refused to say anything and the armed men left. In the week of 9 March, armed men again came to the Delmas district looking for Guy Telva, and again neighbours refused to give them any information. Guy Telva is presently in hiding, unable to return to his home.

He also reported that since December 1991, he has been receiving telephone calls saying that if he does not stop broadcasting he will be "crushed". Guy Telva is a reporter for the Voice of America, a radio station which transmits in Créole from the United States, and is one of the few local journalists still reporting on the current situation in Haiti since the coup in September 1991. He believes the threats may be linked to the reports he is attempting to file outside the country regarding the lack of press freedom and cases of human rights violations in Haiti. These include the case of Jean-Mario Paul, a journalist with Radio Antilles International, in Petit-Goâve, who was arrested in Port-au-Prince on 9 November 1991, and reportedly very badly beaten (see UA 393/91, AMR 36/26/91, 19 November 1991 and follow-up AMR 36/08/92, 17 February 1992). In early March 1992, Guy Telva together with a foreign journalist attempted to visit Jean-Mario Paul, who is reported to be seriously ill in prison in Petit-Goâve, and was refused admission by the sergeant in charge, who reportedly verbally abused him.

The threats against Guy Telva occurred shortly after his involvement in publicizing the case of Jean-Claude Museau, a teacher who died under torture in armed forces' custody. Jean-Claude Museau, who was arrested on 30 December 1991 and accused of sticking up posters of President Aristide, died in hospital on 8 January 1992, two days after he was released, reportedly as a result of beatings he received in custody. BACKGROUND INFORMATION

In a coup on the night of 29 to 30 September, troops overthrew the democratically elected government of President Jean-Bertrand Aristide, who had taken office in Haiti on 7 February 1991. Since then Amnesty International has learned of widespread human rights violations committed by the security forces, including a large number of extrajudicial executions, torture and ill-treatment and mass arrests without warrant.

These abuses have been carried out by uniformed agents of the security forces, or on some occasions, by men in civilian clothes believed to be associated with them.

Since the beginning of the coup in Haiti in September 1990, the news media have been persistently attacked by the security forces. Despite public assurances that freedom of expression would be guaranteed, Amnesty International has learned of numerous incidents of journalists and others working in the Haitian news media being singled out as targets for human rights violations, including extrajudicial execution, arbitrary arrest and ill-treatment.
