HAITI:Camille CÉSAR, aged 52 Camille BAZILE

Following the arrest by members of the armed forces of Camille César and Camille Bazile, in Port-au-Prince in the early days of the <u>coup d'Etat</u> between 30 September and 2 October, Amnesty International has learned that their bodies were discovered at the morgue in Port-au-Prince. The bodies were bullet-riddled.

Amnesty International is concerned that both men, who were members of <u>Front National pour le Changement et la Démocratie</u> (FNCD), National Front for Change and Democracy, the political party which backed the candidacy of President Jean-Bertrand Aristide, may have been extrajudicially executed.

FURTHER RECOMMENDED ACTION: Telegrams/telexes/faxes/telephone calls/airmail letters:

- expressing concern at the apparent extrajudicial executions of Camille César and Camille Bazile;

- asking that a full and impartial investigation be carried out into their killings and that the results be made public;

- urging that those found to be responsible be brought to justice.
