UA 303/92 Ill-treatment and Possible Extrajudicial Execution 30 September 1992

HAITI: Jude DAMUS, aged 26

Marcel ALMONATY, former mayor of Anse d'Hainault

Amnesty International is concerned at reports of the ill-treatment in custody of Jude Damus and the possible extrajudicial execution of Marcel Almonaty in Dame Marie, Anse d'Hainault, Grande-Anse Department.

According to information received by Amnesty International, Jude Damus was arrested on 10 September 1992, by members of the armed forces. His arrest followed an anti-government demonstration which was held on 8 September 1992 in Dame Marie on the occasion of the visit to the town by the Minister of Justice. Jude Damus was initially held in Anse d'Hainault prison where he was reportedly ill-treated on a daily basis after his arrest. Jude Damus was reportedly later transferred to the prison in Jérémie. It was reported that as a result of ill-treatment during the first days of detention, Jude Damus had his arm broken. Amnesty International is concerned for his safety.

Amnesty International has also received information on the recent killing of Marcel Almonaty, the former mayor of Anse d'Hainault under the government of ousted President Jean-Bertrand Aristide. His body, riddled with bullets, and with his eyes gouged out, was found floating in the sea in Anse d'Hainault on 25 or 26 September 1992. Marcel Almonaty was forced to abandon his position as mayor and go into hiding following the coup on 29/30 September 1991. Amnesty International is concerned that he may have been extrajudicially executed.

## BACKGROUND INFORMATION

Troops violently overthrew the democratically elected government of President Jean-Bertrand Aristide, who took office in Haiti on 7 February 1991, in a coup on the night of 29 to 30 September 1991. Since then Amnesty International has learned of widespread human rights violations committed by the security forces, including a large number of extrajudicial executions, torture and ill-treatment and mass arrests without warrant. Several of those detained by the authorities remain "disappeared". These abuses have been carried out by uniformed security force agents or, on some occasions, by men in civilian clothes apparently linked to them (see <a href="Haiti: Human Rights Held">Haiti: Human Rights Held</a> to Ransom, AI Index: AMR 36/41/92, August 1992)

On 19 June 1992 a new prime minister, Marc Bazin was sworn in. Several days before he took office, he pledged before the Haitian Senate to "stop repression and restore freedom of the press". However, Amnesty International is continuing to receive reports of widespread human rights violations.

- expressing concern at the reported ill-treatment in custody of Jude Damus, and requesting that the authorities immediately provide him with adequate medical treatment;
- requesting that the reports of ill-treatment be immediately investigated and that his physical safety be guaranteed while in detention;
- asking that his legal situation be clarified and that he be charged with a recognizably criminal offence or else released;

- asking for an immediate and impartial investigation into the circumstances surrounding the possible extrajudicial execution of Marcel Almonaty and that those found to be responsible be brought to justice.
