Amnesty International is concerned for the safety of the above five students who it is reported were all recently arrested in Port-au-Prince. Pika Buron and another student were reportedly arrested on 12 December 1992 and Jean Gardy, Patrice Joseph and Claudy Ganthier on 27 November 1992.

According to information received by Amnesty International, on 12 December at about 11 am members of the Service d'investigation et de recherches anti-gang, Anti-gang Investigation Service, accompanied by a justice of the peace arrived at the Ecole Normale Superieure (Teacher's College), at the State University of Haiti, with the intention to close it down. Pika Buron and another student were apparently inside the library at that moment, and were reportedly arrested. It is believed the two are detained in the Anti-gang Investigation Service. Pika Buron is an active member of Fedération Nationale des Etudiants Haïtiens (FENETH), National Federation of Haitian Students.

In the early hours of 27 November Jean Gardy, Patrice Joseph and Claudy Ganthier were reportedly arrested in their homes and taken away by members of the Anti-gang Investigation Service. They were apparently accused of being supporters of deposed President Jean Bertrand Aristide. However, members of their family have reportedly been unable to locate them in any police station.

BACKGROUND INFORMATION

Student protests followed a decree issued by the Ministry of Education on 27 November 1992, replacing the staff of the Administrative Councils of schools and Universities. On 1 December at least twelve students were arrested at the Faculty of Agronomy, following protests against the appointment of a new dean. Approximately 20 students were reportedly injured after being badly beaten by soldiers who attacked the protesters. On 7 December 20-year-old student Jean Sony Philogène was shot dead in his hospital bed by unidentified people. The day before he had been arrested by members of the security forces and allegedly brought to a body dump with six others. There he was reportedly shot five times. However, he survived the attack and sought assistance, but was killed the day after. (See UA 380/92, AMR 36/54/92 of 2 December 1992 and follow-up AMR 36/57/92 of 9 December 1992.)

Troops violently overthrew the democratically elected government of President Jean-Bertrand Aristide, who took office in Haiti on 7 February 1991, in a coup on

the night of 29 to 30 September 1991. Since then Amnesty International has learned of widespread human rights violations committed by the security forces, including a large number of extrajudicial executions, torture and ill-treatment and mass arrests without warrant. Several of those detained by the authorities remain "disappeared". These abuses have been carried out by uniformed security force agents or, on some occasions, by men in civilian clothes ostensibly linked to them.

- expressing concern for the safety of Pika Buron, Jean Gardy, Patrice Joseph and Claudy Ganthier, who were reportedly recently arrested by the armed forces in Port-au-Prince;
- asking that their whereabouts and that of the other student reportedly detained be made known and that they be treated humanely in custody;
- asking for information as to the reasons for their arrest and details of their legal situation; that their place of detention be made known and that they be granted access to legal representation and to their families.
