On 12 January 1998, Guadalupe Méndez López was shot dead by members of the Policía Judicial Estatal, (PJE), State Judicial Police, in Ocosingo, Chiapas State, during a demonstration calling for justice for the above mentioned Tzotzil Indians, victims of the Acteal massacre on 22 December 1997 by paramilitary groups. Her three year old daughter, Isabel Santís, and another peasant Lázaro López Vásquez, were shot and seriously wounded during the demonstration. Amnesty International continues to be seriously concerned for the safety of indigenous people in the state of Chiapas.

Reportedly nearly 8,000 indigenous peasants have been forced to abandon their communities in Chiapas State following intimidation and searches conducted by members of the armed forces and paramilitary groups. These have included acts of torture and ill-treatment, the ransacking of villages and the burning of homes. The organisation is alarmed at the lack of action taken by the government to investigate and dismantle paramilitary groups.

# FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish or in your own language:

- calling for an immediate, impartial and through investigation into the killing of Guadalupe Méndez López and the injuries suffered by her daughter, Isabel Santís and Lázaro López Vázquez on 12 January 1998;
- noting that 26 members of the police ae being investigated in relation to her killing and requesting to be kept informed of the results of this investigation;
- -seeking assurances that Isabel Santís and Lázaro López Vázquez receive medical attention and protection;
- seeking assurances that measures will be taken to guarantee the safety of the indigenous population in the state of Chiapas;

## if possible also :

- calling on the federal and statal authorities to immediately address the increasing militarization and mushrooming of paramilitary groups in Mexico which has contributed to a human rights crisis;
- requesting the authorities to ensure that the security forces, including the army, at all times and in all places fully uphold international human rights standards.
