Fears for the safety of 20 people detained by members of the security forces during the current official clampdown against alleged members and sympathizers of the Zapatista National Liberation Army (EZLN) have been heightened by reports that at least one of them has been tortured in custody.

Ramiro Arciniega Martínez, school head teacher and leader of the teachers' union in Tehuacán, state of Puebla, was detained by members of the army and the *Policía Judicial Federal (PJF)*, Federal Judicial Police, on 11 February. On 12 February he was taken to the *Reclusorio Oriente*, a prison in Mexico City, where he reportedly told a judge that he had been tortured to force him to confess his alleged involvement with the EZLN.

Gustavo Cervantes Pérez and Martha Carrillo López were detained in Guadalajara, state of Jalisco on 10 February and reportedly accused of keeping an arms cache. Javier Rosas Gómez, accused of being an EZLN member, was detained in the town of Tezonapa, state of Veracruz, by PJF members on 11 February. Their place of detention is not known. Francisco Aranda Tinajero, leader of the *Coalición Obrero Campesina Estudiantil de Sonocusco (COCES)*, Coalition of Workers, Peasants and Students of Sonocusco, was reportedly detained in Tapachula, state of Chiapas, on 11 February. He is presently at the *Penal Tres*, a prison in Tapachula. Víctor Hugo García Santiago was reportedly detained on 11 February by PJF members, in Orizaba, state of Veracruz. He is presently held at the PJF's police station in *El Fortín de las Flores*, in the state of Veracruz.

The 14 other people listed above were reportedly detained in Jacala, state of Hidalgo by 200 members of the security forces. They were all taken to the local Attorney General's Office (*Procuraduría General de la República*) in the city of Pachuca, state of Hidalgo.

Amnesty International has received reports of the torture and ill-treatment of at least 15 people detained by the security forces during the last few days (see UA 31/95, AMR 41/02/95, 13 February and follow up AMR 41/05/95, 14 February; also UA 36/95, AMR 41/06/95, 15 February, and follow-up AMR 41/08/95, 16

February).

BACKGROUND INFORMATION

In a press statement on 9 February, President Ernesto Zedillo called for the arrest of several EZLN leaders, including sub-commander Marcos, whom he named as Rafael Sebastián Guillén Vicente. The President also released the names of four other alleged leaders of the EZLN and arrest warrants were issued against all five. Arrest warrants were also issued against several other alleged EZLN members.

Amnesty International fears that recent events may result in further human rights violations. In the earlier armed clashes which began on 1 January 1994, at least 145 people are reported to have died before a cease-fire was called in mid-January 1994. In the period 1 January 1994 to the present Amnesty International has documented widespread human rights violations in the context of the ongoing conflict, including the summary execution of prisoners, extensive use of torture, and "disappearances" perpetrated by members of the Mexican Army. To date no member of the security forces has been brought to justice for these violations.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing concern at the reported torture of Ramiro Arciniega Martínez by members of the Federal Judicial Police;

- calling for a prompt and impartial investigation into these allegations and for those responsible to be brought to justice; asking to be kept informed of the outcome of these investigations;

- urging immediate measures to ensure the physical and mental integrity of all detainees (naming some of the above), and seeking assurances that all are being humanely treated and are being allowed immediate access to doctors, their relatives and lawyers.
