José Tila López and witness testifying before international human rights observers in Chiapas State

On 21 February 1998 a group of indigenous people was reportedly ambushed by members of the paramilitary group "Paz y Justicia", Peace and Justice, killing José Tila López and wounding several people. The attack took place in Tila municipality, Chiapas state. Hours before José Tila López had given evidence about human rights violations against peasants and indigenous people to an international delegation of human rights observers presently in Chiapas state.

José Tila López, a Chol Indian peasant from Yosijha, but displaced to Tzaquil, a village in the northern part of Chiapas, was part of a small group of indigenous peasants who had testified about human rights violations carried out by members of the security forces, as well as by paramilitary groups.

Members of the group who witnessed José Tila López's killing have given the names of the attackers to the international delegation. The names are also to be formally handed to *Procuraduría General de la República*, (PGR), Attorney General's Office, with a request for an investigation.

On 23 February, members of the international delegation plan to take further testimonies during a visit to communities in the north of Chiapas. This is an area renowened for violence, partly due to the impunity enjoyed by paramilitary groups. The delegation also intends to visit José Tila's relatives, including his father, who witnessed the killing.

FURTHER RECOMMENDED ACTION: Please send faxes/express/ airmail letters in Spanish or in your own language:

- urging that immediate measures be taken to guarantee the safety of all witnesses giving evidence to the international human rights delegation, following the killing of José Tila López on 21 February 1998 in Chiapas state; urging a prompt, impartial and effective investigation into the killing of José Tila López, that the findings be made public, and that those found responsible to be brought to justice;
- requesting an investigation into the impunity enjoyed by paramilitary groups operating in Chiapas, and to bring those responsible for human rights violations to justice;
- urging the authorities to take necessary steps to disband the paramilitary groups.
