Maximino Marcial Jaimes, a member of a peasant farmer environmentalist organisation, was reportedly abducted on 13 March 2000. Amnesty International is concerned for his safety.

Maximino Marcial Jaimes is from the community of Pizotla, municipality of Ajuchitlán del Progreso, Guerrero state, and is a member of the Peasant Farmer Environmentalist Organisation of the mountains of Petatlán and Coyuca de Catatlán, *Organización de Campesinos Ecologistas de la Sierra de Petatlán y Coyuca de Catatlán.* He was on the Coyuca de Catatlán bridge when some men approached him, threatened him with a pistol, forced him into a truck and drove off.

According to reports, those responsible are thought to be members of "paramilitary groups" or "armed civilians" linked to local economic interests and political bosses (*caciques*), which themselves have, according to reports in recent years, been linked to the military in the region.

On 16 March Maximino Marcial Jaime's relatives visited various police stations, the Public Ministry in Guerrero (*Ministerio Público de la Procuraduría de Justicia de Guerrero*), the 40th Infantry Battalion army base and the state offices of the Attorney General of the Republic (*Procuraduría General de la República*) seeking information on his whereabouts but without success.

BACKGROUND INFORMATION

On 2 May 1999, soldiers from the 40th Infantry Battalion entered Pizotla. They shot and killed Salomé Sánchez Ortíz and arbitrarily detained Rodolfo Montiel Flores and Teodoro Cabrera García, who were reportedly held in incommunicado detention for six days and tortured (see UA 144/99, AMR 41/12/99, 25 June 1999 and follow up AMR 41/18/99, 28 July 1999). Both were also members of the Peasant Farmer Environmentalist Organisation of the mountains of Petatlán and Coyuca de Catatlán. Other members of this organisation and communities associated with it have received threats on a number of occassions in recent years.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

-expressing concern for the safety of Maximino Marcial Jaimes, reportedly abducted on 13 March 2000 on the Coyuca de Catatlán bridge, allegedly by "paramilitary groups" or "armed civilians";

-urging the authorities to open a prompt, impartial and thorough investigation into the reported abduction and whereabouts of Maximino Marcial Jaimes;

-in the light of the abduction of Maximino Marcial Jaimes, calling on the authorities to guarantee the safety of members of the Peasant Farmer Environmentalist Organisation of the mountains of Petatlán and Coyuca de Catatlán and inhabitants of Pizotla, municipality of Ajuchitlán del Progreso, Guerrero state.
