Cenebio Sixto Santos Death in custody

There are serious concerns for the safety of five people, Erminio Sánchez Sixto, Emiliano Sánchez Sixto, Feliciano Pérez Nájera, Seferino Sixto and Feliciano Téllez, who were reportedly detained by members of the Mexican Federal Army during a house raid in Barrio Nuevo San José, municipality of Tlacoachistlahuaca, Guerrero State on 26 March 1998.

17-year-old Cenobio Sixto Santos reportedly died as a direct result of a severe beating by soldiers during the raid. Erminio Sánchez Sixto is believed to have had his legs and ribs broken.

The Mexican Federal Army entered the Barrio Nuevo San José community on the morning of 26 March and raided several houses, allegedly searching for arms. At 6pm the same day, a Mexican Federal Army helicopter arrived and took Erminio Sánchez Sixto, Emiliano Sánchez Sixto, Feliciano Pérez Nájera, Seferino Sixto and Feliciano Téllez away to an unknown destination.

It is unclear where the body of Cenobio Sixto Santos has been taken or whether it has been subjected to an independent autopsy.

Members of the Barrio Nuevo San José community are understood to have filed a complaint before the authorities regarding the incident.

BACKGROUND INFORMATION

Barrio Nuevo San José is in an area known as a stronghold for peasant and indigenous rights activists. Amnesty International has documented a systematic pattern of human rights violations against peasant and indigenous activists by members of the security forces as well as by paramilitary groups in the states of Guerrero, Oaxaca and Chiapas.

Many cases of abuse have occurred in the context of counter-insurgency operations in which security forces have linked indigenous activists to the armed opposition groups *Ejército Popular Revolucionario* (EPR), Popular Revolutionary Army, based in Guerrero and Oaxaca States, and the *Ejército Zapatista de Liberación Nacional* (EZLN), Zapatista Army of National Liberation, based in Chiapas State.

RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in or your own language:

- urging that appropriate measures be taken to guarantee the safety of Erminio Sánchez Sixto, Emiliano Sánchez Sixto, Feliciano Pérez Nájera, Seferino Sixto and Feliciano Téllez;
- -urging the authorities to immediately make public their whereabouts and to ensure that they have immediate access to doctors, lawyers and their relatives; -urging that they be charged with a recognizable criminal offence or be promptly

- calling for a prompt, independent and full investigation into teh manner, cause and circumstances surrounding the death of Cenobio Sixto Santos, for the findings to be made public, and for those responsible to be brought to justice.
