On 20 November 1994 the 10 people named above were detained by members of the *Policía de Seguridad Pública*, Public Security Police, while taking part in a peaceful demonstration in the city of Comitán, state of Chiapas. Their whereabouts are unknown and Amnesty International fears for their safety.

At least one other person received gunshot wounds when the security forces tried to disperse the demonstrators.

BACKGROUND INFORMATION

On 16 November, scores of people were seriously injured when members of the security forces tried to disperse a peaceful march in Palenque, state of Chiapas. The whereabouts of dozens of people detained by the security forces during the march remain unknown and there are fears for their safety (see UA 405/94, AMR 41/21/94, 17 November 1994).

Chiapas has long been the scene of continuing human rights violations by the security forces in the context of land disputes and allegations of electoral fraud. These violations have included massive and arbitrary arrests, torture, ill-treatment and political killings. A large number of the victims of such abuses belong to the poorest sectors of the population, and include women and children. Very rarely have those responsible been brought to justice.

On 1 January 1994, hundreds of armed peasants, calling themselves the EZLN, took control of several towns in the state of Chiapas. There was heavy fighting for several days. On 12 January the government declared a ceasefire, although there were reports of continuing land attacks by the armed forces during the following days. An Amnesty International delegation visiting the area in late January confirmed earlier reports of a number of human rights abuses, including the extrajudicial execution of at least five rebels and the torture of rebel and civilian detainees at the hands of the security forces.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing serious concern for the safety of the ten people named above (naming some or all) whose whereabouts remain unknown since being arrested by the Public Security Police on 20 November in Comitán, state of Chiapas;
- calling for the authorities to immediately make public their place of detention, and for them to either be charged with recognizable criminal offences, or to be immediately released;

- seeking assurances that the ten are being humanely treated and are allowed access to their relatives, doctors and lawyers;
- calling for an inquiry into the circumstances of their detention and for steps to be taken to prevent the holding of civilians in unacknowledged detention.
