UA 151/03 Fear for safety 29 May 2003

MEXICO Raúl Gatica (m), indigenous political activist

Amnesty International is concerned for the safety of Raúl Gatica, indigenous activist and head of the Consejo Indígena Popular de Oaxaca "Ricardo Flores Magón" (CIPO -RFM), Popular Indigenous Council of Oaxaca, following a break-in at his house in Oaxaca State and a graffitied death threat against him.

According to reports, on 24 May, Raúl Gatica entered his house in San Isidro Monjas, municipality of Xoxocotlan, Oaxaca State, and found that it had been broken into and vandalised. Books, magazines, personal documents and possessions had been destroyed and his home was left in chaos. However no possessions were reportedly stolen. When he and other members of CIPO- RFM started to clear up, they reportedly found a skull grafitted on the floor with "Raúl" and "You're dead (*Estas muerto*) written next to it. Members of CIPO-RFM took photos of the vandalized house and reported the inicident to the *Procuraduría General de Justicia del Estado* (PGJE) of Oaxaca, State Proscutor's Office.

Raúl Gatica is the leader of the CIPO-RFM, an indigenous political movement in Oaxaca, which promotes activism and indigenous rights in various communities in the state. Both the organization and Raúl Gatica have reportedly suffering repeated threats and harassment over a number of years. In February 2002, Raúl Gatica, and two other membres of CIPO-RFM received several death threats (see UA 21/01, AMR 41/005/2001, 26 January 2001 and follow-up, AMR 41/010/2002, 26 February 2002).

### **BACKGROUND INFORMATION**

Human rights defenders and community political activists are frequently the target of threats and harassment in Oaxaca State. Scores of Oaxaca's many marginalized and impoverished indigenous communities are riven with community conflicts and violence which are frequently manipulated and exploited by *caciques*-local political henchmen - and state authorities. Organizations which promote activism or indigenous rights within communities may be considered to be subversive by the local authorities and have been the target of threats and harassment.

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern for the safety of Raúl Gatica, head of the Popular Indigenous Council of Oaxaca "Ricardo Flores Magón" (CIPO-RFM) following the break-in at his house and the reported death threats against him:
- calling on the authorities to take immediate steps to guarantee the safety of Raúl Gatica in accordance his wishes;
- urging an immediate, full and impartial investigation into the break-in and death threats, and for the results of the investigation to be made public.
