Killed: Viviana Rayas (f), aged 16

Viviana Rayas, who was reported missing on 16 March, has been found dead near a road which leads to the town Delicias, in Chihuahua State. Her body was discovered in an isolated area on 28 May by two passers-by. According to reports, she may have been there for two to three months.

Her family identified the clothes found on the body as those that Viviana was wearing on the last day they saw her. According to the authorities, an analysis of the dental remains confirmed her identity. Viviana's body presented an advanced state of decomposition and had visible signs of torture.

According to reports, the Attorney General of the State of Chihuahua (*Procurador General de Justicia del Estado de Chihuahua*) announced the arrest of three men and a woman on 31 May and 1 June in connection with the murder. There is no further information at this stage.

There is also presently no further information about Marisela Ortiz Rivera who featured in the last update.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing deep sympathy for the murder of Viviana Rayas, who has been found dead on 28 May;
- calling for an immediate investigation with the full collaboration of state and federal institutions into the murder of Viviana Rayas, and for those responsible to be brought to justice;
- calling on the authorities to guarantee that any judicial process on the case is subject to international fair trial standards:
- reiterating to the authorities the urgent necessity of a full, effective and impartial investigation of all cases of women who have been murdered or gone missing in Chihuahua state in similar circumstances;
- calling on the authorities tot take effective steps to prevent, investigate and punish violence against women in Chihuahua state.
