George Anne Potter, a member of the Unitarian Universalist Committee of Boston, Massachussets, was arbitrarily expelled from Mexico on 25 April 1997, following the withdrawal of her visa by the Mexican authorities.

Amnesty International continues to be concerned that international human rights defenders visiting Mexico may continue to be arbitrarily expelled from Mexico, in an attempt to curtail their peaceful activities.

Amnesty International calls on the Mexican Government to make effective their stated commitment to guarantee the free exercise of the right of all human rights defenders to promote and defend human rights within the Mexican territory.

PLEASE CONTINUE ACTION:

- expressing serious concern at the arbitrary expulsion of George Anne Potter, a human rights defender, from Mexico, following the withdrawal of her visa by Mexican immigration officials on 21 April 1997, in Oaxaca, state of Oaxaca; reminding the authorities of their publicly stated commitment to an open-door policy on international human rights defenders, and urging them to reiterate this in the light of the deportations of Vilma Núñez and Benjamín Cuéllar and George Anne Potter;
- urging that all human rights defenders be allowed to carry out their peaceful activities in Mexico, in line with the Mexican Government's international commitments.
