MEXICO José Lavanderos Yáñez, human rights lawyer

On 2 October 1995 José Lavanderos Yáñez, lawyer and member of the non-governmental human rights organization, Centro de Derechos Humanos Agustín Pro-Juárez (PRODH), Human Rights Centre Agustín Pro-Juárez, received death threats. The threats, made anonymously, are believed to have been a result of José Lavanderos Yáñez's work as a lawyer of a group of detainees accused of being members of the Ejército Zapatista de Liberación (EZLN), Zapatista National Liberation Army, an armed opposition group. Some of the detainees have reportedly been tortured to extract confessions.

The threats against José Lavanderos Yáñez, who is also a founding member of the Frente Nacional de Abrogados Democráticos, National Front of Democratic Lawyers, follow systematic harassment and threats against other PRODH members in recent months, apparently with the aim of undermining the Centre's efforts to defend human rights. The Jesuit order, which founded PRODH, has for a long time been the target of a smear campaign, in which its members have been falsely accused of involvement in guerrilla activities.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/airmail letters in Spanish or your own language:

- expressing concern at the death threats against José Lavanderos Yáñez;
- urging the government to take immediate measures to guarantee the safety of José Lavanderos Yáñez and of all members of the *Centro de Derechos Humanos Agustín Pro-Juárez*;
- calling for steps to be taken immediately to identify those responsible for the threats and for them to be brought to justice:
