A joint police and paramilitary operation against two neighbouring communities in Chiapas state have left one person dead and two others "disappeared". Twelve other people, mainly indigenous Tzotziles, have been arrested and are feared to be at risk of torture in custody.

On 17 July 1996, San Sebastian and Señor del Pozo, two hamlets in the community of Venustiano Carranza, Chiapas state, were raided by heavily armed members of the Policía Judicial del Estado (PJE), State Judicial Police and the paramilitary group "Alianza San Bartolomé de los Llanos". The latter is a group linked to the party in power, Partido Revolucionario Institucional, PRI, the Institutional Revolutionary Party. Helicopters were used in the attack. The police and paramilitaries opened fire against community members, including women and children, resulting in the killing of Manuel Martínez de la Torre. Twelve people, most of whom are members of the non-violent Organización Campesina Emiliano Zapata, OCEZ, Emiliano Zapata Peasants Organization, were arrested. In the past OCEZ members have suffered attacks and death threats in connection with their activities on behalf of the local indigenous and peasant population.

The day before, 16 July, two other Tzotziles members of OCEZ from Venustiano Carranza, Valentín de la Torre Mendoza and Rafael Vázquez de la Torre, were abducted by members of the PJE and the paramilitary group. They have not been seen since.

Amnesty International remains seriously concerned for the safety of inhabitants of San Sebastian and Señor del Pozo. Some 300 state police are reported to still be in the area.

BACKGROUND INFORMATION

Amnesty International is seriously concerned about continuing human rights violations in the state of Chiapas, particularly in view of the current wave of arrests, threats and harassment against members of the peasant communities apparently targeted exclusively because of their activities on behalf of the peasant population.

Three Amnesty International delegations have visited Chiapas: in January 1994, January 1995 and June 1996. During these research visits Amnesty International has recorded a long-term pattern of rural violence relating to land-tenure conflicts in Chiapas state. Particularly during the last visit the organization was able to document the pattern of human rights abuses committed by hired gunmen acting on behalf of local chiefs linked to the ruling PRI party.

In May 1996, 23 families fled their homes in Bachajon, state of Chiapas, and since then have taken "refuge" in the auditorium of Tuxtla Gutiérrez, the capital of Chiapas. They have been unable to return to their homes out of fear for their safety, fears which have been heightened by reports that members of paramilitary groups, who ransacked and burned their homes, are still "patrolling" at liberty and threatening villagers with complete impunity (see UA 120/96, AMR 41/21/96, 7 May 1996 and update 10 May).

The failure to bring to justice those responsible for human rights violations and the lack of effective action to stop them and to end such impunity, has apparently helped to fuel an increasing number of threats and attacks against human rights defenders and peasant activists. A well known non-governmental organization, based in Chiapas, has just released a document on the 102 killings reportedly committed by members of the security forces and death squads in the period January to April 1996 in Chiapas State.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in Spanish or your own language:

- condemning the apparent extrajudicial execution of Manuel Martinez de la Torre by members of the State Judicial Police and the paramilitary group linked to the PRI, "Alianza San Bartolomé de los Llanos", urging a prompt and full investigation into his death and asking to be kept informed of any findings; calling for an immediate and impartial investigation into the whereabouts of Valentín de la Torre Mendoza and Rafael Vázquez de la Torre who "disappeared" on 16 July 1996, urging that if in detention they be humanely treated and allowed access to relatives, doctors, interpreters and lawyers;
- expressing concern for the safety of all the peasants detained (name some), in Venustiano Carranza, state of Chiapas on 17 July 1996 and urging that they be charged with a recognizable offence or released immediately;
- expressing deep alarm about continuing human rights violations in the state of Chiapas, and the apparent lack of effective action to stop them and to end the impunity currently enjoyed by most perpetrators.
