An organisation working for the rights of indigenous people in southern Mexico has received an email death threat. Their work has frequently been opposed by local political bosses (caciques), and Amnesty International is concerned for their safety.

The Union de Organizacioes de La Sierra de Oaxaca (UNOSJO), Union of Organizations of the Sierra Juárez of Oaxaca, works to promote and defend indigenous rights in the Sierra Juarez region of Oaxaca state. Two members of the organisation, Aldo González and Melina Hernández Sosa, are felt to be at particular risk, as their work has been particularly high-profile.

The e-mail death threat, which arrived at the UNOSJO offices on 1 November, said: "this is the moment to execute all those who feed off the people, people like you who deceive and make promises, I know who you are..."

BACKGROUND INFORMATION

Human rights defenders make a vital contribution to strengthening the rule of law, civil society and the development of institutions to protect human rights. However, in Mexico those who struggle to defend the rights of others have often been the first to come under attack, and to have their own rights violated and their safety threatened. Human rights lawyer Digna Ochoa was assassinated on 19 October; earlier this month human rights defenders in Mexico City and in other parts of the country received death threats. Human rights defenders in Oaxaca have faced repeated threats and harassment for a number of years. The authorities have consistently failed to bring those responsible to justice.

Caciques are powerful figures in many areas of Mexico, particularly in southern states such as Oaxaca and Chiapas. They frequently control the political and economic life of rural areas, and can act with impunity because they enjoy the tacit or direct support of the local authorities and state security forces.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish, English or your own language:

- expressing concern for the safety of members of Aldo González, Melina Hernández Sosa and other members of the *Union de Organizacioes de La Sierra de Oaxaca*, who received an email death threat on 1 November 2001;
- calling on the authorities to guarantee the safety of those at risk and provide them with appropriate protection;
- calling for an immediate, thorough and impartial investigation into the threat, with the results made public and those responsible brought to justice; reminding the authorities of the right of human rights defenders to carry out their activities without any restrictions or fear of reprisals, as set out in the United Nations Declaration on the Rights and Responsibilities of Individuals, Groups and Institutions to Promote and Protect Universally Recognised Human Rights and Fundamental Liberties.
