On the afternoon of 28 August 1996, Pilar Noriega and Digna Ochoa, human rights lawyers and members of the *Centro de Derechos Humanos Agustín Pro-Juárez* (*PRODH*), Human Rights Centre Agustín Pro-Juárez, received an anonymous letter at the PRODH's office in Mexico City, announcing their death in a week's time.

This is the latest of a series of threats against members of PRODH, which appear to be related to the lawyers' work in defending seven people imprisoned under unfounded charges of having links with the *Ejército Zapatista de Liberación Nacional (EZLN)*, Zapatista National Liberation Army, whom Amnesty International believes are prisoners of conscience (see original UA).

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing grave concern about continuing death threats against lawyers Pilar Noriega and Digna Ochoa, apparently as a result of their human rights work; - urging the government to adopt immediate and effective measures to ensure their safety and to carry out full investigations in order to bring those responsible to justice;

- requesting to be kept informed about the results of such investigations.
