Prison officals have threatened to kill the wife of an inmate if she continues to file complaints on behalf of her husband. Other prisoners are in danger of reprisals for filing complaints against the prison authorities.

Adrián Martín Gómez Pérez is serving a three and a half year sentence in Apodaca prison, Nuevo León state, for possession of arms. On 13 December Adrián Gómez was reportedly taken out of his cell and beaten around the back and head. One guard put a cord around his neck, threatening to strangle him, and pulled the cord until he passed out.

Prison officials told her not to visit her husband, and added that if she continued to file complaints then they would see to it that she had an accident.

Adrián Gómez, Sergio Bustamente Hernández and other inmates have been victimised by the prison authorities for filing complaints about illegal deprivation of freedom, being denied access to telephones and visitors, ill-treatment and threats. The *Comandante de Vigilancia*, prison Head of Security, has told them that none of them will make it out alive.

Amnesty International also fears for the safety of Luciano Rodriguez Linares in Topo Chico prison, also in Nuevo León state who claims he is at risk of reprisals for previously filing a complaint. Luciano may also be being targetted because he is gay. On 7 December he was taken out of his cell and beaten. A prison officer reportedly inserted a finger in his anus, drawing blood. The officer told him he would be killed if he filed a complaint.

There have been frequent reports of torture and ill treatment in prisons in Nuevo León. The state authorities have consistently denied such reports. For example, in October, a prisoner was ill-treated as punishment after human rights activists staged a peaceful protest outside the Topo Chico prison to launch the Amnesty International campaign against torture (see AI Index: AMR 41/57/00, November 2000)

-urging the authorities to take all steps necessary to guarantee the safety of Adrián Martín Gómez Pérez, his wife, Sergio Bustamente Hernández and other inmates of Apodaca prison, and Luciano Rodríguez Linares and other inmates of Topo Chico prison;

-calling on the authorities to conduct full, prompt, and independent investigations into the allegations, to make the findings public, and to bring those responsible to justice.
