UA 272/97 "Disappearance" / Fear of torture 14 August 1997

MEXICOEverardo Salgado Román, political activist

On 11 August 1997, Everardo Salgado Román, an active member of the *Partido de la Revolución Democrática* (PRD), Party of the Democratic Revolution, was abducted in the town of Iguala, Guerrero State. He has not been seen since. Amnesty International fears that he has been arbitrarily detained by members of the security forces on account of his political activism. The organization is deeply concerned for his safety.

Everardo Salgado was travelling in a vehicle with three other men when, at 12.30am, it broke down. A truck pulled up and according to reports, four masked men in civilian clothes got out. Without producing any form of identification, they forced Everardo Salgado and one on of his companions, Mardonio Alvarez, into the truck, blindfolded them and drove them away. After a short time they released Mardonio Alvarez, saying that he was of no use to them.

Efforts by Everardo Salgado's relatives and other PRD members to locate him have been unsuccessful, and state authorities have denied having any record of his detention.

BACKGROUND INFORMATION

Amnesty International has documented dozens of cases of serious human rights violations against members of the PRD, peasant and community activists, as well as human rights defenders in states such as Guerrero and Oaxaca. The mid-term congressional elections in July 1997 contributed to heightened political tension particularly in these two states which have a record of human rights violations and impunity from prosecution for the perpetrators. The activities of the insurgent *Ejército Popular Revolucionario* (EPR), Popular Revolutionary Army, an armed opposition group which operates in the region, have given the security forces an excuse to target all forms of opposition, including legal political parties.

RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish or your own language:

calling for the whereabouts of Everardo Salgado Román to be made public immediately, for his family to be informed, and for him to be released;
seeking assurances that if he is in detention he is being treated humanely;
calling for an prompt and full investigation into the arbitrary detention of Everardo Salgado Román and for the perpetrators to be brought to justice;
expressing deep alarm at the increasing number of reports of human rights violations in the state of Guerrero, the apparent lack of effective action to stop them and the impunity currently enjoyed by most perpetrators.
