Staff members of the non-governmental human rights organization, *Centro de Derechos Humanos Agustín Pro Juárez*, *A.C. (PRODH)*, have received further death threats. Amnesty International remains deeply concerned for their safety.

Those named in the latest threats are three PRODH lawyers, Pilar Noriega, Digna Ochoa, Víctor Brenes, and the Director of the Centre, David Fernández Dávalos. The threats, consisting of anonymous text written on separate pages for each one of those named, and marked with a black cross, were discovered in the mailbox at PRODH's office in Mexico City, at 3:15pm on 26 November. The text announced the imminent death of those named, as well as Víctor Brenes' daughters.

The death threats are the latest in a series made against staff of PRODH, a highly respected human rights organization in Mexico. The threats have become more aggressive and contain more and more personal details of those named. Despite formal complaints and thousands of international appeals to the authorities, nobody has been brought to justice for making threats.

Amnesty International fears that the Mexican Government's apparent acquiescence with the growing number of threats and attacks against human rights defenders, and the corresponding impunity of perpetrators, may lead to gross human rights violations against activists, including those named above.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing deep concern about the latest death threats against Pilar Noriega, Digna Ochoa, Víctor Brenes and David Fernández Dávalos, staff members of the PRODH, and about the impunity with which such threats have continued agains PRODH, and expressing dismay that nobody has been brought to justice for earlier threats;
- seeking clarification as to why the authorities have been unable to fully investigate the threats, and urging the authorities to adopt immediate and effective measures to prevent further threats and attacks;
- expressing solidarity with those threatened as well as outrage about the situation being faced by human rights defenders in Mexico, and emphasising Amnesty International's commitment to continue campaigning for the protection of such activists.
