USA (Texas): Danny Ray HARRIS

Danny Harris is scheduled to be executed in Texas, USA, on 30 July 1993. He was convicted of the murder of Timothy Merka, white, in December 1978, along with three others, including his younger brother, Curtis Harris. Curtis Harris, who was only 17-years-old at the time of the murder, was executed on 1 July 1993.

Danny Harris, black, was first sentenced to death in February 1980. His first death sentence was overturned on appeal, but he was resentenced to death at a second trial in July 1984. Danny Harris was 18-years-old at the time of the crime.

If Danny Harris' execution goes ahead as scheduled, it will be the second execution of a young offender in Texas in four weeks. The scheduling of executions in Texas of young offenders follows the denial of the appeal by the US Supreme Court in another Texas death penalty case, Dorsie Johnson v State of Texas. This appeal had claimed that the pre-1991 Texas capital statute under which Dorsie Johnson (a 19-year-old offender at the time of the crime) was sentenced was unconstitutional in not allowing consideration of a defendant's youth as a separate mitigating circumstance at the sentencing stage of a capital trial. The Supreme Court rejected this appeal by a narrow majority of 5-4 votes. In a strong dissenting opinion, Justice O'Connor, joined by three other justices, said she would have allowed the appeal as the former Texas law ignored the most relevant mitigating aspect of youth: its relation to a defendant's "culpability for the crime he committed". This ruling has effectively paved the way for the execution of at least a dozen young offenders in Texas (including juveniles who were aged under 18 at the time of the crime) whose cases had been stayed pending the outcome of the Dorsie Johnson appeal.

Danny Harris is one of nine children and was brought up in extreme poverty. According to an affidavit testimony by one of his relatives, Danny Harris' father was an alcoholic who became extremely abusive towards his children when drunk.

Amnesty International opposes the death penalty in all cases as a violation of the right to life, and the right not to be subjected to cruel, inhuman and degrading treatment or punishment, as enshrined in the Universal Declaration of Human Rights.
