USA (Texas) Harold Joe LANE Thomas Joe MILLER -EL Jorge CORDOVA

Harold Joe Lane, white, Thomas Joe Miller-El, black, and Jorge Cordova, hispanic, are scheduled to be executed in Texas on 4, 17 and 25 October respectively.

Thomas Miller-El was sentenced to death for a murder committed during a robbery in 1986. According to information received by Amnesty International, Miller-El was in extremely bad health during his trial and was still suffering from the effects of being shot by police while being arrested. The trial judge had ordered Thomas Miller-El's medication to be stopped and he drifted in and out of consciousness for much of the three month hearing.

Thomas Miller-El's wife, Dorothy, was also convicted of the same offences and sentenced to imprisonment for two life terms. However, Dorothy Miller-El's conviction was overturned on appeal in 1990 and she was released in 1992. The prison authorities have refused Dorothy Miller-El permission to be with her husband during his execution on the grounds that she has a prison record, in spite of the fact that her conviction was overturned.

Thomas Miller-El was convicted by a jury comprised of 11 whites and one black after the prosecutor had removed 10 prospective black jurors from the jury-pool. It appears that the one black member of the jury may have been selected because of his opinions on the death penalty. When asked about the death penalty, he replied that "the person who committed such a crime should be staked to an ant bed and have honey poured on him".

Harold Joe Lane was convicted for the fatal shooting of a supermarket employee, Tammy Davies, during a robbery in 1982.

Amnesty International has been unable to obtain any further information on Jorge Cordova.

Amnesty International opposes the death penalty in all cases as a violation of the right to life and the right not to be subjected to cruel or degrading punishment, as proclaimed in the Universal Declaration of Human Rights.

## BACKGROUND INFORMATION

Amnesty International is deeply concerned at the number of executions being carried out in the USA in general, and in Texas in particular. Of the 299 executions carried out in the USA since the death penalty was resumed in the mid 1970s, 99 have been carried out in Texas. The method of execution is lethal injection.

In Texas, the governor may commute a sentence of death only if he receives a favourable recommendation from the Board of Pardons and Paroles. The Board consistently refuses to hold full clemency hearings in death penalty cases, and apart from a number of commutations granted in the 1980s as the result of two key court rulings, the Board has never recommended clemency in any death penalty case in recent years.

As of 31 August, 1995 there were 401 prisoners under sentence of death in Texas. The most recent person to be executed in Texas was Jimmy Jeffers on 13 September 1995.

urging the Board to recommend that Governor Bush grant clemency to all three;

- expressing opposition to the death penalty in all cases.
