VENEZUELA: Second Anniversary of El Amparo Killings

On 29 October 1988, fourteen peasants from El Amparo in the state of Apure were killed by a combined unit of military personnel and members of the security forces near the border with Colombia (see UA 26/89 (AMR 53/02/89, 25 January, and follow-ups AMR 53/04/89, 7 April, AMR 53/05/89, 5 May, and AMR 53/07/89, 26 October).

In the two years that have passed since the incident took place, there has been little progress in the proceedings and the military courts conducting the investigations have issued a series of often controversial rulings. However, according to reports, the case is currently being studied by President Carlos Andrés Pérez who, as Commander-in-Chief of the Armed Forces (the highest authority for appeals in the military courts), can decide whether the case should continue or not, and it is thought that appeals and publicity at this stage could result in the case being kept open.

A decision by the Supreme Court (<u>Corte Suprema de Justicia</u>) on 26 June 1990, brought renewed hope to the relatives of the victims. The maximum court annulled as inappropriate three rulings by the military court of appeal (<u>Corte</u> <u>Marcial</u>) which had favoured the 19 members of the unit implicated in the incident. In addition, the Supreme Court confirmed that charges of <u>homicidio</u> <u>intencional</u> (murder) should be brought against the 19 men, thereby ratifying the Permanent War Council of San Cristóbal's (<u>Consejo de Guerra Permanente</u> <u>de San Cristóbal</u>) decision at the end of 1988 to issue arrest warrants against the 19 men.

According to reports, 14 of the 19 members of the unit are in detention in the <u>Cárcel de Santa Ana</u> (Santa Ana Prison) in San Cristóbal in the State of Táchira. The defence lawyers acting on behalf of the survivors and the relatives of the fourteen victims, have presented formal complaints of <u>homicidio</u> <u>intencional</u>, uso indebido de arma de fuego y simulación de hecho punible (homicide, unlawful use of firearms and of falsifying evidence) against the 19 members of the unit before the Permanent War Council of San Cristóbal.

RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters:

- expressing serious concern at the long delays in the court proceedings and that two years after the incident took place and inspite of the strong evidence that the fourteen peasants were the victims of extrajudicial execution, those responsible have not yet been brought to justice;

- noting the Supreme Court's decision to uphold the charges against the 19 members of the unit implicated in the killings and expressing the hope that the case will proceed without further delays and that those responsible will be brought to justice.
