Amnesty International has received new information concerning the arrests of members of the dance troupe *Myo Daw Win Mar Anyeint* (corrected spelling) on 7 January in Mandalay. Their leader, U Pa Pa Lay, had been arrested previously in 1991 when he served a two-year prison sentence for making a political joke against the military authorities and in favour of the National League for Democracy (NLD). U Htwe, the manager of the troupe, is the NLD Chairman of the Mandalay Southeast Township.

Daw Myaing and Ma Yin Tin Swe, two assistants to the dancers, were arrested on 11 January. U Myint Thein and U Aung Soe, NLD members who had helped to arrange the troupe's performance on 4 January, were arrested on 12 January. There is still no information about where the 12 are being held, or if they have been charged and tried.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/airmail letters in English or in your own language:

- seeking assurances that the treatment of those arrested in connection with the dance troupe *Myo Daw Win Mar Anyeint* conforms to international standards and that they are being given proper access to family, lawyers of their choice and medical personnel;

- seeking information about the whereabouts and the exact charges against them; - urging that, if they have been arrested solely for exercising their rights to freedom of expression and association, they be immediately and unconditionally released.
