Unofficial reports now say that more than 50 members of the National League for Democracy (NLD) were arrested between 23 and 31 October 1990. Those arrested include at least ten members of the Myanmar national assembly elected in May, five members of the Central Executive Committee of the NLD, which overwhelming won those elections, and ten NLD party youth organizers. Reports now specify that all eight members of the leadership of the student-dominated Democratic Party for a New Society (DPNS) have been arrested. Security forces are said to have shut and sealed up many NLD and DPNS offices.

Unofficial reports name a fourth member of the NLD Central Executive Committee arrested as Kyaw Min. Three other top NLD figures arrested have been named as Tin Htut, a member of the league's Central Work Committee, and Aung Khin Sint and Sein Hla Oo, identified as leaders of the NLD at the level of Myanmar's divisions.

There are now allegations that the military authorities who administer Myanmar through their State Law and Order Restoration Council have begun imposing what are described as "trumped up charges" against political prisoners by "making up criminal charges" against them. At the same time, it has been reported that the military is moving political prisoners from the Myanmar main prison at Insein to detention centres outside Yangon (Rangoon), the capital.

Amnesty International is concerned that all the prisoners named above may in fact be held because of their peaceful exercise of the rights to freedom of expression and assembly and other fundamental freedoms. It is also concerned that any of them who may have been moved to detention centres outside Yangon would be particularly vulnerable to torture or other ill-treatment by interrogators and warders. It is concerned that any charged with criminal offences may not receive fair trials.

RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters:

- expressing concern that Khin Maung Swe, Chan Aye, Soe Thein, Kyaw Min, Tin Htut, Aung Khin Sint, Sein Hla Oo and other political leaders and students arrested since 23 October may be detained solely for the peaceful exercise of their rights to freedom of expression and assembly;
- urging that unless they are to be charged with a genuinely criminal offence and fairly tried, they should be released immediately and unconditionally;
- urging that their treatment in detention conform to international standards and that they be given access to their families and lawyers of their own choice.
