1993 death penalty photographs

Nine photographs are reproduced on the following pages, with captions explaining each picture.

Photographs one and two are a series taken in Beijing in June 1993.

Photographs three, four and five are a series taken in Yunnan province in the latter half of 1993.

Photographs six, seven and **eight** are a series taken from a photographic display cabinet on show to the public in Chengdu city, Sichuan province in November 1993.

Photograph nine was taken in Lanzhou city, Gansu province sometime in 1993.

Beijing, June 1993.

Wang Junping, convicted of train robbery, stands in the centre of the photograph wearing a flat cap flanked by policemen. Wang Zudong and Shi Wushun charged with collaboration in the robberies stand on the right and far left respectively. Their hands are tied behind their backs to wooden posts. The posts and placards round their necks state their crime and name. The three men having been sentenced to death are being publicly paraded in Beijing before being taken to the execution ground to be shot.

Prisoners lying dead after the execution has been carried out. In the foreground, still wearing his flat cap, lies Wang Junping. The policemen who carried out the execution can be seen to the far left holding their rifles. Prisoners are usually shot in the back of the head, although from the photograph it is not clear if this was the method used in the case of Wang Junping and the other prisoners.
