Medical Concern/Fear of Ill-treatment 18 June 1993

People's Republic of China:Ren Wanding

In a letter sent to the World Conference on Human Rights in Vienna, Zhang Fengying, the wife of Ren Wanding, a human rights activist jailed in China since 1989, has asked the United Nations to consider the plight of her husband.

In her letter to the U.N., dated 16 June 1993, Zhang Fengying expresses concern that her husband, who is serving his seven-year sentence in Beijing Prison No.2, may now be subjected to punishment because of an incident which happened at the prison on 15 June during her monthly visit. According to her account Ren Wanding was mistreated by prison guards after requesting to see his medical file, from which he believed records had been removed in order to prevent his release on medical grounds. The prison guards became angry at this request, twisted Ren Wanding's arm behind his back, put a hand over his mouth and took him away claiming he would undergo a "severe punishment". As he was being taken back to his cell, Ren Wanding declared that he would go on hunger strike in protest.

Amnesty International fears that as a "severe punishment" Ren Wanding may be placed in solitary confinement, which could lead to a further decline in his physical and mental well-being. The organization is also concerned about the effects a hunger strike may have on his state of health.

Ren Wanding's health appears to have deteriorated considerably since his imprisonment. He is reportedly suffering from severe internal and external haemorrhoids, acute gastritis, as well as chronic sinusitis and chest infections. He has developed cataracts that have seriously reduced his vision and is in danger of losing his eyesight completely. He has apparently not received any specialist medical treatment.

Ren Wanding was arrested in Beijing in 1989 for distributing essays and making speeches calling for respect for human rights, freedom of speech and the rule of law, during the 1989 pro-democracy protests. A veteran human rights activist, he had been previously jailed for four years after founding the "Human Rights Alliance" in Beijing during the 1979 "Democracy Wall" movement. FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or your own language:

- expressing concern that Ren Wanding, who has not used or advocated violence,

has been detained for the peaceful exercise of the right to freedom of expression and urging that he released immediately and unconditionally;

- urging that he receive proper medical care appropriate to his state of health in accordance with the $\underline{\text{United Nations Standard Minimum Rules for the Treatment}}$ of Prisoners.
