Further Information on UA 156/06 (ASA 17/032/2006, 2 June 2006) <u>Fear of torture and ill-treatment/Detention without charge/Medical concern</u>

Alim, Ablikim and Kahar Abdiriyim, sons of ethnic Uighur activist Rebiya Kadeer, are facing criminal charges brought by the Chinese authorities.

Alim Abdiriyim reportedly confessed under torture on 1July to the alleged crimes of "tax fraud" and "splittism", or advocating independence for the Xinjiang Uighur Autonomous Region (XUAR). According to the USbased non-governmental organization Uyghur Human Rights Project (UHRP), Alim Abdiriyim was transferred to the Tianshan District detention centre in Urumchi, the capital of the XUAR, following his "confession". He may need urgent medical attention for injuries sustained during torture.

Ablikim Abdiriyim is reportedly still in hospital after being beaten by police officers in early June, soon after he was first detained. His medical condition and legal status are unclear but he has been charged with "tax fraud" and "subversion". Kahar Abdiriyim, the elder brother of Alim and Ablikim, has also been charged with "tax fraud" and is being held at the Tianshan District detention centre. All three were formally charged on 13 June.

Alim and Ablikim Abdiriyim were detained along with their sister Rushangul and six other family members (four of them children) on 29 May, in an apparent attempt to prevent them from meeting with a United States Congressional Team which was scheduled to visit them the following day. The delegation included representatives of the US Congressional Human Rights Caucus. The official Chinese press, however, reported that the nine were detained due to alleged financial irregularities in Rebiya Kadeer's business. All except one of Rebiya Kadeer's family businesses have been closed or ordered to suspend activities. On 1 June, Alim and Ablikim Abdiriyim were beaten by police in front of their children and in front of Rushangul, who was then handed a mobile phone and told to call Rebiya Kadeer in the USA and tell her what was happening. Rushangul was later taken to hospital to be treated for symptoms related to stress and shock. She and Rebiya Kadeer's brother Mamat Kadeer are currently reported to be under house arrest. The four grandchildren of Rebiya Kadeer who had been detained were released, but are reportedly being prevented from leaving their homes to attend school. There is no further information on Kaysar and Rayila, who were detained along with the four children.

#### **BACKGROUND INFORMATION**

Rebiya Kadeer is a former Amnesty International prisoner of conscience. Her family was subjected to harassment by the authorities following her initial detention in 1999 and has experienced intensified persecution since she was released from prison on medical parole on 17 March 2005. She was sent to the

USA on her release. Prior to being freed, Rebiya Kadeer claims she was warned that if she engaged with members of the Uighur ethnic community or spoke publicly about "sensitive issues" after her release, her "businesses and children will be finished". Rebiya Kadeer was recently elected President of the Uyghur American Association which established the UHRP. Since her release, Chinese police have launched an investigation into alleged financial irregularities by her company, the Akida Trading Co in Urumqi. Rebiya Kadeer has repeatedly denied any wrongdoing. Amnesty International considers that the ongoing harassment and reports of torture and ill-treatment of Rebiya Kadeer's family cast serious doubt on the credibility of this investigation.

# **RECOMMENDED ACTION:** Please send appeals to arrive as quickly as possible, in Chinese, English or your own language:

- expressing deep concern about the reported beating of Ablikim Abdiriyim and torture of Alim Abdiriyim and calling on the authorities to launch a full, independent and impartial investigation into the allegations with a view to bringing those responsible to justice;

- calling on the Chinese government to guarantee that Ablikim, Alim and Kahar Abdiriyim have access to lawyers of their choice, to family members and any necessary medical treatment;

- calling on the authorities to lift restrictions on the freedom of movement of Rushangul Abdiriyim and Mamat Kadeer;

- requesting immediate guarantees for the safety of all individuals (five adults and four children) in detention or under house arrest;

- calling on the authorities to bring an end to human rights violations directed at members of Rebiya Kadeer's family, including arbitrary detention, police harassment and other restrictions on their freedom of expression and association.
