PEOPLE'S REPUBLIC OF CHINA: Liu Gang

Prison authorities have reportedly forbidden Liu Gang's family from visiting him for at least one year. Liu Gang's father, Liu Guichun, and his sister, Liu Ming, were informed of this decision during a recent visit to the prison in north-east China, where Liu Gang, the 32-year-old former student leader, is serving a six-year sentence. They were apparently given no reason for the decision. Liu Ming reportedly sustained an injury to her head in a scuffle with a prison guard as she tried to insist on seeing her brother. The family, who live in Jilin Province in north-east China, travelled to Beijing in the first week of December to report the incident to the Justice Ministry and to call for action.

Amnesty International is concerned that Liu Gang's family have been denied the right to visit him in prison, particularly in view of reports that Liu Gang has been repeatedly ill-treated at the prison since 1991. It is also concerned that his sister was injured by a prison official as she insisted on seeing her brother. Liu Ming is particularly concerned that she will no longer be able to monitor her brother's state of health.

For the past two years there have been repeated allegations that Liu Gang and other political prisoners held in Lingyuan No.2 Labour-Reform Detachment in Liaoning Province have been subjected to torture and other forms of ill-treatment since their arrival. In August 1993, Amnesty International published a document entitled "Appeal for Liu Gang" (AI Index: 17/34/93), which describes Liu Gang's own account of the appalling living conditions in prison and the brutal ill-treatment he has suffered.

Since the publication outside China in Spring 1993, of Liu Gang's account of his situation, the authorities in Beijing have denied that he was tortured and in bad health. In one report by the official English-language magazine Beijing Review, published in late August 1993, Liu Gang's claims that he was ill-treated were refuted with the statements of prison officials and the magazine concluded that there was no evidence that he was ill-treated.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in English or your own language:

- expressing concern that prison authorities have denied Liu Gang's family the right to visit him in prison in accordance with the United Nations Standard Minimum Rules for the Treatment of Prisoners, and urging them to reverse this decision;
- urging the authorities to release Liu Gang immediately and unconditionally and to ensure that he receives all appropriate medical care;
- expressing concern that no action appears to have been taken by the authorities

to investigate previous allegations of ill-treatment of prisoners in Lingyuan, or to ensure the prisoners' safety and take other appropriate measures, such as the suspension from duty of all officers alleged to have either ordered, used or acquiesced to the use of torture;

- urging the authorities to take such measures without delay, particularly to ensure prisoners' safety, and to launch an impartial investigation by an independent authority into the allegations of torture and ill-treatment at Lingyuan, the results of which should be made public.
