PEOPLE'S REPUBLIC OF CHINA (PRC): ZHANG Weiguo, 35-year-old journalist

Zhang Weiguo was released from custody on 21 August 1991, according to Beijing-based journalists who have spoken to him. Zhang Weiguo, aged 35, was the Beijing bureau chief of the World Economic Herald, a Shanghai-based weekly newspaper noted for its reformist views which was closed by the Chinese authorities in April 1989. He had been detained as a prisoner of conscience, without charge or trial, from June 1989 to 12 February 1991, for his alleged participation in the 1989 pro-democracy movement. He went into hiding in June 1991 after giving an interview to BBC TV journalists. He was detained again on 30 July 1991 at the home of relatives in Zhejiang province.

He was reportedly held in a military camp near Shanghai where he was extensively interrogated on his alleged contacts with the foreign press and foreign personalities. He was reportedly released after his mother signed a document guaranteeing on his behalf that he would not leave Shanghai; he was told that he could be re-arrested at any time.

### FURTHER RECOMMENDED ACTION: Telexes/faxes and airmail letters:

- welcoming the release of Zhang Weiguo, but expressing concern at the arbitrariness of his three-week-long detention solely for exercising his right to freedom of expression and freedom of movement;
- expressing concern that Zhang Weiguo's mother was reportedly requested to act as a guarantor as a condition of his release;
- urging the authorities to lift any conditions they have set on Zhang Weiguo's release and which may impair his freedom of expression and movement.
