Those prisoners whose death sentences are confirmed are usually then executed immediately after the rally. A 'sentencing' rally is one where the initial pronouncements of sentences may occur. Execution should not take place until the sentence has been approved and confirmed by a higher court. Many rallies are reportedly used to both sentence in the first instance and confirm sentences.
