INDIA (JAMMU AND KASHMIR)GUL MOHAMMAD NAIK MUSHTAO AHMAD

Released: MOHAMMAD YOUSUF GABROO

Mohammad Yousuf Gabroo was released on 20 January. The Special Operations Group [SOG], a police division created to combat militant activity in Jammu and Kashmir, continue to hold Gul Mohammad Naik and Mushtaq Ahmad without charge in Humhama village in the Badam district of Srinagar, the state capital.

Mohammad Yousuf Gabroo, who is around 58 years old, was apparently severely tortured while in detention. He has said that he was hung upside down from the ceiling and beaten, and that a heavy metal roller was rolled over his body. Both these methods of torture are reportedly used extensively by the SOG. As the three detainees were held seperately, he could not say anything about the condition of Gul Mohammad Naik and Mushtaq Ahmad.

The three men, who work for the State Forest Corporation, were detained by the SOG on 16 January when they visited a police station to report that they had been abducted by the the armed opposition group Lashkar-i-Toiba, who had hijacked their vehicles for use in an attack on Srinagar airport. Bilal Ahmad Mir, a fourth man who was detained at the same time, died while in custody. His body reportedly bore the marks of severe torture.

- asking the authorities to guarantee that Gul Naik and Mushtaq Ahmad are not subjected to torture or other forms of ill-treatment while in custody;
- urging that they are given prompt and regular access to their families, lawyers and any medical treatment they may require;
- urging that they be charged with a recognizably criminal offence and brought before a magistrate within 24 hours, or be immediately released;
- urging the authorities to immediately order an independent and impartial inquiry into the death of Bilal Ahmad Mir and the torture of Mohammad Yousuf Gabroo, and to ensure that those found to be responsible are brought to justice; calling on the authorities to order impartial, independent and transparent inquiries into all incidents of torture and deaths-in-custody within the state.
