## INDIA Azam Ali

The Andhra Pradesh government has ordered a judicial inquiry into the killing of human rights defender Azam Ali, who was working with the Andhra Pradesh Civil Liberties Committee (APCLC). The Home Minister announced the inquiry in a statement to the Legislative Assembly, in which he condemned the killing.

Amnesty International welcomes the inquiry, but remains concerned that the state government has not provided vital information about the scope of the inquiry, how long it will last and who will be in charge.

If the state authorities really intend to prevent further human rights violations and ensure the safety of human rights defenders in Andhra Pradesh, Amnesty International believes that any inquiry should also investigate the wider issue of alleged police connivance with the killers of both T. Purushottam and Azam Ali. There are reports that police failed to investigate when the people who claimed responsibility for the death of T. Purushottam threatened to attack human rights defenders working with the APCLC, and that police have refused to conduct a judicial inquiry into the killing.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- asking the government of Andhra Pradesh for details of the remit of the inquiry, the date for completion and name of the Judicial Officer who will head the inquiry;
- asking them to ensure that the inquiry looks into allegations that the killers had links to state security forces;
- urging the government of Andhra Pradesh to make all necessary information available to the inquiry so that they can conduct an impartial and independent investigation;
- calling on the state authorities to provide protection for any witnesses who give evidence before the inquiry.
