INDIA Civilians in Jammu and Kashmir

and new concern: House arrest of political leaders

Leaders of the All Parties Hurriyet Conference (APHC) (an umbrella organization of over 30 opposition groups in Jammu and Kashmir) have been placed under house arrest in Srinagar, Jammu and Kashmir, a day before elections take place in the Srinagar and Udhampur districts of the state. Omer Farooq, Shabir Shah, Syed Ali Shah Geelani, Abdul Gani Bhat and others have been prevented from leaving their homes by security forces. The homes of several other leaders including Abdul Gani Lone, Yasin Malik and Javed Mir have also been cordoned off by security forces.

Amnesty International fears for the safety of these leaders while under house arrest. In recent months, leaders of the APHC have been the target of numerous attacks (see background below). The APHC has alleged that those responsible for the attacks are members of armed groups operating with the support of security forces (known as "renegades").

Amnesty International is gravely concerned at this action by security forces in Jammu and Kashmir which it believes is an attack on the right to freedom of expression. Shabir Shah had recently called for peaceful demonstrations to oppose elections which are to take place on 30 May. A recent demonstration in Baramulla town was broken up by security forces using teargas and batons during which journalists and others were injured.

FURTHER BACKGROUND

Political leaders, including leaders of the APHC have been the target for several attacks by unidentified persons. On 11 April 1996 grenades were thrown into the houses of Abdul Gani Lone and Syed Ali Shah Geelani — the third attack on them in only a few weeks. Abdul Gani Lone has been quoted as saying "We are afraid of the gun, whoever holds it. Whether it is the "renegades", the security forces or the militants. In case elections are held, the people will be ground between them". Government authorities consistently claim that these attacks are perpetrated by armed opposition groups. However, "renegades" have been fully implicated in many of these attacks.

The APHC has called for a boycott of elections in the state and has called instead for tripartite talks between the Government of India, the government of Pakistan and representatives of Kashmiris in Jammu and Kashmir.

Shabir Shah, Abdul Gani Lone and Syed Ali Shah Geelani have been the focus of previous Amnesty International action as political prisoners, detained for many years under legislation which Amnesty International believes contravenes international standards.
