Released: Saiful Bahri (24), student Mauli Iskandar (23), student Maimun (21), student

Saiful Bahri, Mauli Iskandar and Maimun are now known to have been released in the evening of 26 June, the same day that they were taken from their homes by the military. They said that they had been detained at Aceh Besar District Military Command (Kodim), where the four others are still held.

Their relatives tried to visit the four at the Kodim on 29 June, but were told that all four had been transferred to police custody. However, the local police station (*Police Resort, Polres*) said that the army had not handed over any detainees to them.

The relatives went back to the Kodim today, and were apparently told that the four were still detained there, but they were not allowed to see them.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in Bahasa Indonesia or your own language:

- calling on the authorities to guarantee that Jafaruddin Fajar, Abdullah Abra, Zikri and Syukriadi Syahputra will not be subjected to torture or other human rights violations;

- asking for them to be released immediately and unconditionally if they are not charged with a recognizably criminal offence, in which case they should be transferred immediately into the custody of the police;

- urging the authorities to ensure that, if they are not to be released, they are given immediate access to lawyers, their families and medical treatment.
