Fear for safety 20 July 20

Eleven human rights activists are in police custody in Aceh. They have been subjected to ill-treatment and there is continued concern for their safety.

On 20 July the Police Mobile Brigade (Brimob) raided the offices of the Banda Aceh branch of the *Lembaga Bantuan Hukum* (LBH), Legal Aid Foundation, where a meeting was taking place to discuss arrangements for a week-long campaign against militarism, which began on 16 July. Around 27 Brimob officers entered the offices. One of them fired a shot into the air. Those attending the meeting were forced to squat on the floor and take off their shirts. A police officer beat one of them. They were taken out to the yard, where they were forced to lie face down on the ground. After around one hour, 15 committee members and activists were taken to Aceh Besar District Police Headquarters (Polres Aceh Besar). Four of them have since been released. The others remain in custody. It is unclear whether they have had access to a lawyer.

During the raid documents, photographs, a computer and other equipment was confiscated.

LBH is among the oldest and most prominent human rights organizations in Indonesia. In Banda Aceh it shares an office with another human rights group, the *Komisi untuk Organg Hilang dan Korban Tindak Kekerasan* (Kontras), Commission for Disappearances and the Victims of Violence. A member of Kontras from Banda Aceh, who had been detained with one other person on 17 July, was released on 18 July. He was severely tortured while in police custody.

BACKGROUND INFORMATION

Serious human rights violations, including unlawful killings, torture and arbitrary arrests, are continuing in Aceh during military and police operations against the armed opposition group, the *Gerakan Aceh Merdeka*, (GAM) Free Aceh Movement. New military operations began in May 2001, and hundreds of extra troops have been sent to the province. Local human rights groups estimate that over 1,000 people - many of them civilians - have been killed in the conflict so far this year. Anyone detained by the police or military in Aceh is at grave risk of torture or other human rights violations.

The level of threats and intimidation directed against human rights defenders in Aceh has intensified in recent months. Human rights defenders have been the victim of extrajudicial executions, arbitrary detention and torture. Others have been accused of criminal offences which are believed to be primarily

intended to intimidate them and to discourage them from continuing their human rights work. An increasing number of activist have had to leave the province for their own safety.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Bahasa Indonesia or your own language:

urging the authorities to guarantee that the 11 human rights activists in detention will not be tortured or subjected to other human rights violations;
calling on the authorities to immediately and unconditionally release them;
urging the authorities to launch an immediate, independent investigation into the arbitrary arrest of the activists, and into allegations that they were ill-treated on arrest.
