Thirty-two out of the forty people arrested on 26 and 27 November have now been released. This includes twelve of those arrested on 27 November, in connection with pro-independence ceremonies and twenty people arrested at a meeting in the Fandini Dalam area of Manokwari town on 26 November.

Of those still detained Dominggus Anto, Bernardus Acame, Manfred Bame, Zeth Dimara, Karel Kasima and Boas Sraun were arrested at around 6 am on 27 November after raising the Morning Star flag – a symbol of Papuan independence. Keliopas Fenitruma and Rudi Fenitruma were arrested during the meeting in the Fandini Dalam area on 26 November. The two are reportedly being held because they were carrying ammunition and a knife.

Amnesty International is concerned that the remaining eight men are being prevented from communicating in confidence with their lawyers. They have not yet been charged and are being held in Manokwari Police Resort, Manokwari District, Papua Province where they are still considered to be at risk of torture or ill-treatment.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Bahasa Indonesia, English or your own language:

- acknowledging the release of the 32 people detained between 26 and 27 November 2002, but urging that the remaining eight be immediately and unconditionally released unless they are charged with a recognizably criminal offence:
- urging the authorities to guarantee that the eight men who remain in Manokwari Police Resort will not be tortured or ill-treated;

- urging that they are given access to lawyers of their own choosing, that communications between detainees and their lawyers are confidential and that lawyers can accompany them when being questioned.
