Four other men, see names above, are now known to have been arrested in connection with the planned meeting in Jayapura in support of independence for the province of West Papua. Lawyers are being denied access to the men and all are, therefore, at risk of ill-treatment.

The four men were arrested on 30 September 1998 and placed in detention alongside Don Falsy at Polres (Police Resort), Jayapura.

Amnesty International also fears that others could be arrested, and thereby placed at risk of ill-treatment, in connection with the planned meeting, after three men: Ronald Sapirattu, Max Krey and Martinus Felimon were summonsed by police in Jayapura for their alleged involvement.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Bahasa Indonesia or English or in your own language:

- urging the authorities to grant the five men immediate, regular and on-going access to independent legal counsel and to ensure they are not ill-treated;
 urging the authorities to release all five men if they are detained solely for the peaceful expression of their beliefs in support of West Papuan independence;
- seeking assurances that no additional arrests will occur in connection with plans to hold a meeting in Jayapura to discuss independence of the province; reminding the government of Indonesia of its commitment to the Universal Declaration of Human Rights, in particular Article 19: "Everyone has the right to freedom of opinion and expression..."
