It has just been confirmed that Khairulla Khan and Shorin Khan were executed on 30 April. According to unconfirmed reports, Hassim Escandar, Assidin Itting and Anthony Najali have also been executed.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or your own language:**

- expressing deep regret that Khairulla Khan and Shorin Khan have been executed;
- expressing grave concern that they have been executed despite trials that may not have met international fair trial standards;
- inquiring about the present status and circumstances of Hassim Escandar, Assidin Itting and Anthony Najali;
- stating Amnesty International's opposition to the death penalty in all cases as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading punishment, as proclaimed in the Universal Declaration of Human Rights;
- urging that all death sentences be commuted and that no more death sentences be imposed;
